I am sending along our post-event report from the Cystic Fibrosis Foundation's Great Rides Tulalip Drive-In Movie on August 10th.

Thank you so much for sponsoring our [Great Rides Tulalip Drive-In Movie](#) on August 10th, 2024. We had a fantastic evening and so far we have raised \$26,754.61! The proceeds from this event will be used to support the mission of the Cystic Fibrosis Foundation, to cure cystic fibrosis and to provide all people with CF the opportunity to lead long, fulfilling lives by funding research and drug development. This month, the Cystic Fibrosis Foundation and University of California, Berkeley's Bakar Labs announced Positivo Biotechnology as the winner of this year's CF Foundation-sponsored [Golden Ticket Competition](#), which awards one year of free office and lab space at Bakar Labs to a company developing [genetic therapy](#) technologies that could be applied to cystic fibrosis. To help advance the company's technologies, the Cystic Fibrosis Foundation will also provide access to its disease-specific resources and expertise. This is an exciting development and couldn't be done without the support of sponsors like the Tulalip Tribes Charitable Foundation.

During the Great Rides Tulalip Drive-In Movie, the community enjoyed a showing of Kung Fu Panda 4 movie on a large blow-up screen in the Boom City Parking Lot. We estimate that there were around 90 cars in attendance carrying around 250 attendees. We opened the gates earlier this year to allow our attendees to take full advantage of the fantastic selection of food trucks and to enter our raffle. We had food options from local food trucks like Kona Ice, Teepee Creepers, Big House of Doggs, Jared's CORNER, Bite Me Mini Pancakes, Big Red Truck, Lolita's Tacos, Antojito's Mexican Snack Bar, and Hotbox BBQ available for purchase. We also had Emerald Kingdom Parties, a character actor company, donate their services with Peter Pan, Tinkerbell. Those two characters, as well as a homemade Kung Fu Panda character, walked around the lot to greet families! Kelsie Pablo, our event chair and also a mother of a child with cystic fibrosis, organized a drawing which included close to 40 donated items including gift cards, sports tickets, toys, and baskets. We raised approximately \$3,600 from these items! We had a brief program before the film to thank all of our attendees, donors and sponsors including Tulalip Cares. Folks who donated over \$100 to the event received an official CFF Great Strides t-shirt which included the Tulalip Tribes logo on the back.

We are expecting to fundraise around \$31,000 before the end of the year through additional fundraising. Locally, your sponsorship helps support CF Fighters including Keldan Pablo, a teenage member of the Tulalip Tribes, as well as Kaidynce Olsen, a teenage girl living in Marysville. Our programs and fundraisers help Keldan, Kaidynce and

others living with CF living all around Washington state. We are so grateful for the support of the Tulalip Tribes Charitable Foundation and are looking forward to next year's event!
