Closing Report:

The provided by the Tulalip Tribes Charitable Fund was integral to our education program's success during the COVID-19 pandemic. When the bill could not be picked up by our other grants, we relied on the Tulalip Cares grant. The majority of these funds supported continual employment for our education team, while the remainder covered some supply costs.



This past year was tumultuous for our school partners and their students. Initially, field trips to North Creek Forest were not an option. Instead, we provided in-person outdoor lessons to private schools on their campuses, and hosted public schools virtually. Once public schools

went hyrid in April, we adapted lessons for the natural areas on their campuses. Overall, we hosted 12 classes outdoors and 25 classes virtually from January - August.



We exceeded our goals for individual classes and students reached and total hours students spent with our team. Although, we reached one fewer school than hoped and our at-home activities for virtual lessons were unfruitful due to concerns regarding equal access to the outdoors, adult supervision, and supply distribution. This severely decreased their time spent on activities and projects. Desp te this, we worked with 3 schools for the first time and have extended our services into the Lake Washington and Edmonds School Districts.



Teachers from each school expressed interest working with us in the future, most of which we already have scheduled events for. We received no feedback from parents regarding our athome activities since those were unable to occur. Student comprehension was well noted by teachers, although engagement was difficult to monitor virtually. Once inperson, student engagement was clear and enthusiastic. Unfortunately, we were unable to facilitate student research projects, which resulted in there being no student presentations to attend.

This project period didn't proceed as initially planned, but still exceeded our expectations. We wouldn't have achieved all that we did without your support.
