Dear Marilyn Sheldon,

Thank you for the contribution of [REDACTED] from the Tulalip Tribes Charitable Contributions. The [REDACTED] was used for the [REDACTED] fee for Glacier Peak Institute's first Washington Service Corps members. Without the funding, GPI would not have been able to offer these positions and programs would have ceased. These have been vital to our spring programming. Our only employee, Oak Rankin, sustained a knee injury while teaching youth to snowshoe in February. The WSC members allowed the programming to continue. In the first 3 months that the Tulalip covered the funding, we ran 34 programs with 1,025 hours of youth participating, all but 16 of which were outdoors.

The funding allowed GPI to support coordinate and launch the greenhouse programs at the school. We had 26 programs at the Darrington School District for grades K - 5. We had 478 times youth participated for over 800 hours of youth outdoors. The youth were introduced to growing plants and restoration. We are developing caring and understanding of plants and the local ecosystems. Garden programs have been demonstrated to be more effective than sports programs at increasing the health of the lowest income in a community.

In our after school programming in January through March, there were 16 programs with 90 times youth participated with 46 hours of afterschool programs. This comes to a total of 224 hours of youth in programs. Volunteers provided another 34 hours of support to the programs

- Snowshoeing and maple sap tapping
- Tracking and game camera set up
- Nutrient enhancement of salmon carcasses
- Rafting to count eagles

Few programs in Snohomish County are budgeted to reach Darrington, the school district with the highest free and reduced meal rate in the county. We greatly appreciate Tulalip's generosity to help us invest in a future for youth and the local ecosystems.
