## GSBA Scholarship & Education Fund Q3 2024 14.2 | Final Report

Dear Marilyn,

In January of this year, Tulalip Tribes Charitable Contributions generously granted GSBA an award of [REDACTED] for our Scholarship & Education Fund.

This year, the GSBA Scholarship & Education Fund served 77 LGBTQIA2S+ scholars: the largest cohort our 34-year-old program has ever had! These are students working diligently to pursue higher education in a variety of fields (Arts, Culture & Humanities, STEM, Vocational Trades, Healthcare, Mental & Behavioral Health, Business, and more). This year's cohort is made up of students who are 99% LGBTQ, Indigiqueer, and/or Two-spirit, 54% people of color, 49% living with a disability, 46% from a rural area with limited resources for the LGBTQIA2S+ community, 51% who have experienced housing insecurity, and 47% first-generation college students. These students are already embodying the change we want to see in our communities: they are leaders, artists, and advocates for equity. They are optimistic, dedicated, and courageous in the face of adversity.

Not only does the GSBA Scholarship & Education Fund cover tuition for our Scholars, but we also offer wrap-around support services like leadership development workshops, mentorship and community, stipends for traveling and educational conference fees, career prep field trips, internship opportunities, resume review, emergency grants, and more.

Specifically, the grant from Tulalip Cares increased GSBA's capacity to respond to our scholars' most urgent needs, allowing for 5 more scholars to receive Emergency Grants from GSBA. During the 2024-25 school year, 14 of our scholars were granted emergency funds to cover the unexpected costs of things like car repairs, dental and medical emergencies, missed paychecks due to illness, laptop repair, bike replacement, bill catchup, rent assistance, and gender affirming care expenses. As LGBTQIA2S+ students already face disproportionate barriers to higher education, costs like these can make or

break a student's chances at finishing their program or degree. Thanks to the generosity of Tulalip Tribes Charitable, these students were able to focus on staying in school and pursuing their studies.

Thank you for supporting a brighter future for LGBTQIA2S+ students and making education more accessible to all. GSBA is excited by the opportunity to partner with Tulalip Tribes Cares in the future.
