We, the Board of Advisors for Huy ("Hoyt"), write with our deepest gratitude to you and your Tribe for your financial support of our work on behalf of Native Americans imprisoned in Washington State.

The Tulalip Tribe granted HUY for an April 3, 2018. With your help in 2018 Huy supported Native Americans in all 12 of Washington's State prisons, directly touching all 21 Native American Circles. Huy raised \$25,000.00 in 2017-2018 and distributed \$24,426.26 to the Circles. Your monies helped our relatives within the iron houses of Washington State to engage in religious and spiritual activities like sweatlodge ceremony, drum circle, beadwork and pow wow – all of which we hope will help them find the Good Red Road. We strive to touch every Native American incarcerated in Washington State.

Huy raises monies and receives gifts, to in turn be gifted, for the benefit of such American indigenous prisoners. 
