
Organization's General Goals:

We, the Board of Advisors for Huy ("Hoyt"), write with our deepest gratitude to you and your Tribe for your financial support of our work on behalf of incarcerated Indigenous relatives in Washington State.

The Tulalip Tribes granted Huy \$ on 03/16/2020, Q4 2019 14.2. This grant was intended to support Pow Wow and other services in 2020, but the COVID-19 Pandemic restricted all Native American religious ceremonies from March 2020 until very recently. Huy in turn "froze" all funds until COVID-19 restrictions were eased. On March 12, 2021, we joined with the ACLU of Washington in "requesting that Washington State Department of Corrections (DOC) modify current restrictions on Native American religious ceremonies" and "provide for immediate access to Native American religious expression, including sweat lodge, smudging, talking circles, drum ceremony and pipe ceremony, with the least restrictive Covid-19 precautions necessary". Huy has otherwise asked the DOC to enhance Indigenous religious programming beyond what was made available pre-COVID, for example, by increasing contract funding and causing sacred medicine gardens to be planted statewide. As DOC considered those requests, Huy distributed \$10,500.00 to our 21 Indigenous Circles on March 24, 2021. Huy gifted \$500.00 to each Circle which was used for group medicines, beading materials, or whatever else our relatives needed to endure the pandemic until they could return to sweat lodge and other group ceremonies.

Finally, in August of 2022 our Brothers and Sisters began celebrating Pow Wow again. With your help Huy donated \$1500.00 each to all 21 Circles in the Washington DOC totaling \$31.500.00. They also began again to participate in Inipi (sweat lodge) ceremonies, which are key to preparing prisoners for release and recovery, while healing themselves in a traditional way. Your funds will be used to support traditional foods, regalia and gift making, dancing and drumming circles and outside guests and family members attendance for Pow Wow. Sweat Lodge re-building and maintenance. Inipi ceremony support including medicines, willows, and blankets. Drum maintenance and supplies. There is also Pipe ceremony, and Change of Seasons ceremony, and talking circles, as well as wellbriety trainings such as White Bison Medicine Wheel 12 step teachings and Mending Broken Hearts Intergenerational Trauma Program teachings. Also, sacred medicine gardens have been started in several iron houses and will be instituted in more this coming year.

Huy's mission is to provide economic, educational, rehabilitative and religious support for Indigenous Native Americans and other Indigenous prisoners in the Pacific Northwest and throughout the United States. Huy raises monies and receives gifts, to in turn be gifted, for the benefit of such American Indigenous prisoners. For some Native inmates, walking the Good Red Road while behind bars is the only road to rehabilitation and survival.

Our hands go up to you and yours.




