COMMUNITY IMPACT REPORT | TULALIP CHARITABLE FUND

Project: New Lounge Furniture | Residential Comfort [REDACTED] | Code: Q4 2024 14.2

OVERVIEW

Healing Lodge of the Seven Nations is a culturally specific adolescent residential Substance Use Disorder treatment program serving Native and community youth ages 13–17 from Tribal Nations throughout the region and country. With the generous support of the Tulalip Tribe, Healing Lodge was able to purchase new lounge furniture for the girls' residential wing, PelPalWichiya, creating a more comfortable, welcoming space that supports rest, connection, and healing during treatment.

USE OF FUNDS

Funds were used to replace heavily worn lounge furniture in the PelPalWichiya girls' wing. The previous furniture was damaged, uncomfortable, and no longer appropriate for a therapeutic residential setting. The new furniture provides a comfortable and inviting environment where residents gather for group activities, creative projects, peer connection, and quiet downtime between programming. This shared space now better supports rest, reflection, and relationship-building, all of which are essential to the healing process. Thus far, dozens of residents have benefited, while more than 140 yearly residents are estimated to enjoy the furniture in years to come.

OUTCOMES AND IMPACT

The new lounge furniture has significantly improved the comfort and usability of the PelPalWichiya girls' wing common area. Staff have observed increased use of the lounge for peer bonding, creative activities such as making friendship bracelets or coloring, and informal reflection, all of which support emotional regulation, relationship-building, and a sense of safety. Creating a comfortable, respectful environment reinforces to youth that they are valued and deserving of care, which is an essential component of the healing process.

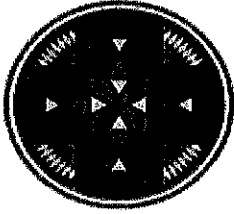

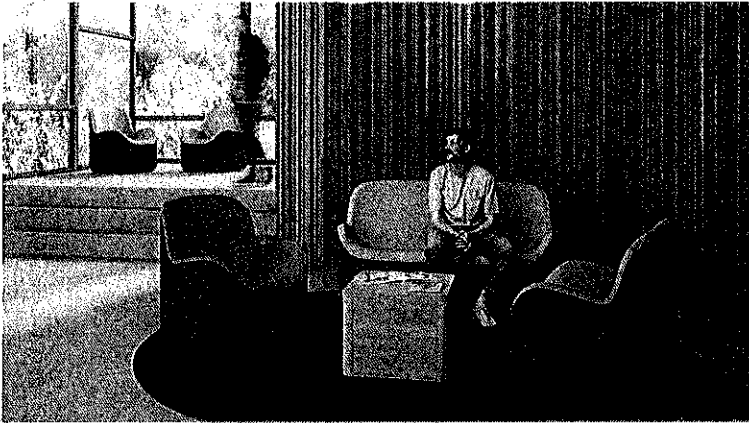
