I hope that you are enjoying the summer. We are very grateful for the Tulalip tribes support over the past 2 years and hope you will consider supporting us again this year. You are, no doubt aware of Marine Conservation Institute's collaboration with the Tulalip tribe and Brad Warren in Snohomish County to look at future changes in sea level in Puget Sound. We are very excited about this work and hope to expand it and share it in other places around the world. Both regionally and globally we are working to maintain healthy oceans by protecting wild ocean places for us, and for our future generations. Understanding the role of climate change is an important aspect of our work.

We consider ourselves a powerful and passionate organization changing the dynamics of ocean conservation. With headquarters in the Pacific Northwest, we are a US-based non-profit 501 (c)(3) organization. Founded in Washington we now have additional offices in the San Francisco Bay Area and Washington D.C. Since 1996, Marine Conservation Institute's science and advocacy work has led to the protection of over 644,000 square miles of ocean which in turn protects our wilderness areas. Last year we played a key role in President Obama's decision to expand protection of the Pacific Remote Islands Marine National Monument. This monument is now one of the world's largest protected area (land or sea). Prestigious international and national media outlets such as BBC, PBS NewsHour, The Guardian, The Washington Post and many others covered our organization's extensive work on the expansion.

The biggest need at the organization currently is support to develop our major initiative, the Global Ocean Refuge System (GLORES, pronounced glôr-ees). GLORES is a strategic, science-based way to safeguard marine ecosystems on a global scale. It is designed to catalyze strong protection for at least 20% of the ecosystems in each marine biogeographic region by 2030, enough to avert mass extinction of marine wildlife.

As you probably know, healthy oceans are essential to human survival and the prosperity of our wilderness areas, but they are in deep trouble worldwide. The best way to maintain the oceans' biological diversity, abundance and resilience is to protect marine life in their ecosystems. A global system of strongly protected marine areas will help to recover marine life so people regain the many benefits of healthy oceans. The SeaStates G20 report that we completed and presented at the IUCN World Parks Congress shows how well the countries with the world's largest economies are protecting the oceans. With currently only 2.09% protected worldwide, much work still needs to be done to reach the 20% target of the Global Ocean Refuge System. This week, Marine Conservation Institute released our US SeaStates 2015 report that looks at how well states and territories safeguard their coastal and marine habitats. This work was featured in our MPAtlas.org exhibit at the Esri User Conference in San Diego last week. The Global Ocean Refuge System is endorsed by a diverse group of folks such as Marine Conservation Institute Board member Dr. Sylvia Earle, Gateway founder Ted Waitt, Royal Geographic and National Geographic Society Fellow Dr. Enric Sala, scuba diving legend Peter Hughes and Mavericks surfer Ryan **Seelbach**. In addition, several other respected marine scientists, world renowned ocean photographers, and companies such as Alaska Airlines, Holland America Line, Seabourn, Un-Cruise Adventures, Gill and **SCUBAPRO**, have joined this initiative.
