Dear Members of the Grant Committee,

We at the Monroe Arts Council wish to thank you again for your award of and a last year, and to follow up on the status of this project. The purpose of this grant was to purchase a professional-quality art display system for the lobby of our venue, the Wagner Performing Arts Center.

You will not be surprised to hear that our plans were impacted significantly by COVID-19. Within days of receiving your grant funds, we were required to cancel all our scheduled performances and close our auditorium. We are still closed, and due to the terms of our lease, we are permitted only minimal access to the building. Of course, the celebration of community art we had planned has not yet taken place.

However, there is good news! We have in fact purchased the display system, and it is in safe storage while we await permission to reopen. The total cost of this system was which would have been unaffordable for us without your funding. A copy of the invoice is enclosed.

We are planning now for an "Urban Sketching" fundraiser which will invite artists of all abilities in our town to participate in creating images of our local landmarks. When we are finally able to reopen the auditorium, the drawings and paintings submitted by the public will become our first exhibit. Our vision is that the display system you helped us purchase will become a cornerstone for encouraging artistic expression among the members of our community.
