Dear Marilyn,

Multi-Service Center (MSC) appreciates your support of our work in the community to provide assistance to South King County to families in need. This funding was helpful by allowing MSC to provide critical financial assistance to families staying at our shelter in ways that were not possible through other funding sources.

Some of the things we were able to do with the funding provided included:

- Providing furniture for a family who had been experiencing literal homelessness, as they moved from our shelter unit into an apartment of their own. MSC has an agreement with Northwest Furniture Bank to provide vouchers so that clients can shop at Northwest Furniture Bank and choose the furniture that best suits their needs.
- Purchased work boots and clothing for some of the individuals newly employed by King County. Families at our shelter were offered the opportunity to apply for temporary King County outdoor park maintenance positions over the summer, as a way to re-enter the workforce, provide some job experience, and the option to apply for other related County positions.
- Provided cleaning supplies, pots, pans, and sheets for a family who moved in to a shelter unit without many standard household items.

From January 2022 through October 2022, MSC provided 3,611 bed nights for families in 15 units comprising our family shelter. MSC served 33 individual people during this time, some families staying a number of months, others ready to move to permanent housing in one or two months, depending on their individual situation. MSC's case manager provided 192 hours of case management hours to these families during this time.
