Report to Tulalip Tribes Charitable Contributions Fund

Support from Tulalip Tribes Charitable Contributions helped low-income Washington students build a habit of savings while leveraging match funds to help with tuition and books. Thank you!

Student debt is set to surpass <u>more than \$1.2 trillion</u> in the U.S., and is fast becoming a national crisis. The true impact of this crisis is most felt among the families and students struggling to find a way to pay for college. Many are looking for alternative ways to afford tuition. That's where MESA comes in. Through MESA, when a student saves up to \$500, the amount they save will be matched 3:1 by the Northwest Credit Union Foundation.

MESA is designed to build students' savings and fiscal capability. In addition to establishing a savings behavior, the participants also complete a financial literacy component. The platform is all online, so students can complete it on their personal time. MESA offers a great incentive to save, and participants learn life-long money management skills, like creating a budget.

Participants are required to save \$25 a month for six months before they can make a qualified withdrawal, and the money can be used to cover tuition and fees or pay for books required for courses at a college, university, technical college or vocational school in Oregon, Washington or Idaho.

The Tulalip Tribes Charitable Contributions' generous support of NWCUF has had a huge impact on low-income students through the Matched Education Savings Account (MESA) program. In partnership with credit unions in Washington, we are helping students avoid student debt while building a habit to save.

Through MESA, when a student saves \$500 for college expenses, the amount he or she saves is matched 3:1. This means Tulalip Tribes Charitable Contributions helped low-income Washington students turn \$500 into \$2,000 for books or tuition.
