Dear Marilyn,

We are so delighted to have been awarded a [REDACTED] grant from the Tulalip Tribes Charitable Contributions. The following is our final report on the impact that the contribution from Tulalip Tribes has had on PROVAIL's programs and clients.

The [REDACTED] contribution from Tulalip helped build a \$25,000 challenge pool that was used to encourage giving during the raise the paddle portion of our Gala Auction event held on May 20, 2017. This year the challenge pool had an amazing impact. The pool leveraged a more than 73% increase in raise the paddle donations – from \$40,620 in 2016 to \$70,350 in 2017! We can't thank you enough for helping us achieve this important, impressive result. With your partnership, we were able to cover significantly more of the cost of the clinic and therapy services for children and youth with disabilities.

This past year our Clinic partnered with Makers Making Change to design one-of-a-kind assistive technology solutions for our clients. One new device that resulted is the Lipsync – a mouth-controlled input that enables individuals with limited or no hand control to accurately use touchscreen devices. Our Clinic also launched a new evidence-based program called Talk with Technology (TWT) to support families with children who are minimally or non-verbal. TWT teaches parents and caregivers how to interact most effectively using a communication device.

Over the past year, funds from the Tulalip Tribes Charitable Contributions supported our Therapy Clinic program to work with a total of 50 children with developmental disabilities. Therapists in our clinic were able to outfit these children with customized technology to meet their individual mobility and communication needs, and provide their teachers, families, and caregivers with training to support optimal independence for each child – at school, at home, and in the community.

Thank you to the Tulalip Tribes Charitable Contributions for making this momentous year possible and allowing our programs to meet even more of the needs of the children with disabilities in our community.
