### **Update:**

August 2018, Schack Art Center was awarded a Tulalip Cares grant to help replace lighting in the Schack Gallery entry and retail gallery with high efficiency LED fixtures.

The gallery entry lights have been replaced (as pictured right). We already see a difference with the Juno LED tracks at the Schack entry. These lights burn 24 hours a day, seven days a week and no replacements have been needed. There are no black holes from burned out bulbs and artwork is not compromised. And, the retail gallery lights are scheduled for replacement January 2020. Our electrical contractor retired before fundraising was complete and we could move forward with the retail replacements. We have

identified a new contractor and January is the *only* month our busy retail gallery can close down for three days to complete this installation.

New LED lighting in the Schack Gallery addresses challenges outlined in our proposal that include: 1) demonstrating environmental stewardship; 2) safeguarding guests and artwork; and 3) maximizing staff efficiency and safety.
