We are thrilled that the Tulalip Tribes Charitable Contributions Fund supported the our 2016 request with a grant for a technology upgrade.

We were not able to raise all funds to complete the project as describe. However, your grant made it possible to purchase:

- Two new HP ProDesk computers/monitors with Windows 10 and a 3 year warranty at \$1,869 each (total of \$3,738)
- An HP Ultrium 3000 Tape Back for the networking system, along HP backup tapes for \$2,735

IT support and labor for the project was \$1,000; and with tax, the total cost was \$8,198.17.

These computers replaced those of staff with the greatest need, our Marketing Manager and our K-12 Education Director. Both manage large files that include high definition graphics and photos of artwork. The new computers and operating software address issues of lost time and materials due to computer crashes.

Brief project Description

We applied Tulalip Tribes Charitable Contributions to a technology upgrade for the purchase, installation and configuring of:

- Two new HP ProDesk computers/monitors with Windows 10 and a 3 year warranty at \$1,869 each (total of \$3,738)
- An HP Ultrium 3000 Tape Back for the networking system, along HP backup tapes at \$2,735

IT support/labor for the project was \$1,000; and with tax, the total cost was \$8,198.17.

Total Impact

This project increases productivity for staff and ensures our computer network is backed up on a daily basis.

How we evaluate success

We evaluate the success of the project based on improved staff morale and productivity, constituent confidence and satisfaction, and a reduction in overall IT service costs.

How the project expanded access to the arts

Strengthening infrastructure increases the Schack Art Center's capacity to serve the community. Through this service, we are able to expand programming and more effectively reach a broader audience, consequently expanding access to the arts throughout Snohomish County and beyond. As just one example, our education director manages programs that impact nearly 14,000 Snohomish County K-12 students and teachers every year. For one thing, a new computer and operating software means that she can process the 1,300+ electronic art submissions for student art competitions without her computer freezing on every file, (and she gets out of the office before 9 pm at night.)

Improvements

Staff is greatly encouraged by the improved productivity resulting from new hardware and software. Communications are improved with vendors and constituents with no delays or loss of information due to "crashing". And, we have already experienced a reduction in IT services that resulted from equipment failure.

Witnessing the improvements, we plan to continue to raise funds to complete a comprehensive technology upgrade and secure new computers for remaining staff!
