In the fourth quarter of 2017 the Tulalip Tribes Charitable Fund provided a [REDACTED] grant to the Holy Rosary Seattle Conference (chapter) of the Society of St. Vincent de Paul, for the purpose of providing emergency assistance to families in West Seattle facing eviction or a shut-off of their utilities.
