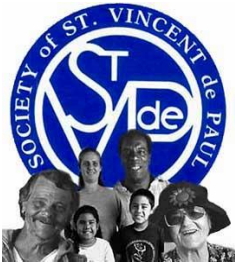

Through your assistance St. Vincent de Paul, volunteers were able to carry out their mission with a spirit of kindness and humanity that is a beacon in the darkness for those oppressed by poverty and despair. Often the awareness that someone cares is as critical to individual or family welfare as the provision of immediate aid. Whether the need is food for a hungry family, emergency funding for utilities or rent, or beds for children, St. Vincent de Paul volunteers provide immediate, concrete assistance to those that often have nowhere else to turn. The Beds for Children program FY 18-19 provided 192 beds.

Thank you for your support of the Beds for Children program for 2019, your donation of [REDACTED] provided 27 beds to vulnerable children. Of special mention, a mother of four whose children were sleeping on one single twin mattress, which was borrowed, was able to find two bunk beds frames and St. Vincent de Paul with your help supplied four mattresses so that her four children were comfortable. With another case, a mother needed two beds for her children and with your timely donation we provided them, we were able to aid another four children in one family with new beds.
