The award of **\$** from Tulalip Tribes Charitable Contributions was applied toward the purchase and installation of acoustic panels for the two studios of The Dance School. Our studio is located at 2821 Rockefeller Avenue in downtown Everett.

During our 2017-2018 season, we were told by the Fire Department that the sound baffles which had been hanging from the ceilings in our two studios for years were partially blocking the automated water sprinklers installed in the ceilings in the case of a building fire. The Fire Department told us this sound baffling did not meet the current fire code, and they had to come down immediately. We tore the sound baffles down, and for several months our students and teachers lived with the increased noise levels in the two studios. The volume of sound produced by the tap classes was loud enough to endanger one's hearing. We searched for a viable solution for new sound baffling that would adhere the Fire Department's code, and we searched for a way to pay for this expensive (and unanticipated) upgrade needed for our studio space.

We identified a company manufacturing acoustic panels that could be wall-mounted, would be compliant with the fire code, and would meet our needs for sound absorption. The **Source** award from Tulalip Tribes Charitable Contributions provided enough funding to make it possible for us to afford the purchase and installation of these new panels. The total cost of the project was **Source**. The Tulalip grant covered more than half of the cost of this project.

During the 2018-2019 season, enrollment at The Dance reached 181 students. During the current 2019-2020 season, enrollment has reached 190 students from 159 families spread throughout Snohomish County. All our students and teachers are very pleased with the noise reduction in the two studios.

We thank the Tulalip Tribes Charitable Contributions for this generous award. This project has truly benefitted all our students and teachers and will continue to do so for many years to come!
