The generous 2024 General Operating grant from the Tulalip Tribes Charitable Contributions has helped fuel another year of significant growth for the True Measure Collaborative (TMC). Your support made it possible for us to expand our reach to **550 educators serving 7,440 students**, strengthen our statewide impact, and deepen the services that help schools create safe, inclusive, and equitable learning environments for all learners. This includes continued expansion of critical special education and multilingual learner supports—along with mental and behavioral health–aligned practices—to meet the growing needs of schools across Washington.

#### **About the True Measure Collaborative**

The True Measure Collaborative (TMC) catalyzes institutional changes in schools that result in increased resources and improved educational outcomes for all students, especially students with disabilities and multilingual learners. The TMC helps schools adopt inclusive and equity-driven educational practices so that all students can thrive.

The TMC supports improved outcomes for students with disabilities and multilingual learners by providing educators with personalized coaching, program consulting, professional development, and increased financial resources. The TMC focused on frequent, intensive, individualized, data-driven coaching for educators. We are particularly proud of the work of our client schools and educator teams, and grateful to be able to help remove barriers to academic achievement for students. Here are a few highlights from this year:

#### 2024–2025 Highlights and Accomplishments

#### **Expanded Reach and Results**

- 550 educators and 7,440 students served across Washington.
- 27 public schools receiving direct coaching, consultation, and professional development.
- Continued strong inclusion results:
  - o 80% of students with disabilities in TMC-supported schools spend most of their day in general education classrooms (vs. 66% state average).
  - Reduction in the use of harmful behavior management practices such as restraint and isolation by 90% and 25% in partner districts
  - Measurable increases in the use of research-based instructional practices proven to improve outcomes for students with disabilities and multilingual learners, such as data-based differentiated instruction and collaboration between General Education and Special Education teachers

#### **Statewide Leadership & Systems Change**

- Selected by OSPI as an approved professional development provider for the statewide *Reducing Restraint and Isolation* initiative, supporting schools in implementing safe, trauma-informed, relationship-centered practices.
- Led statewide coalition and advocacy work, elevating the needs of students with disabilities and multilingual learners and supporting policy solutions that reduce inequities and strengthen inclusive education.
- Served as a thought partner to districts and school leaders navigating compliance, inclusion, staffing, and programming challenges.
