Dear Ms. Sheldon:

I write to provide a report on the Tulalip Tribes' generous contribution this spring, which was applied toward expenses for our Second Annual Indigenous Peoples' Day Celebration on October 12, 2015.

2015 Indigenous People's Day Celebration

The 2015 celebration drew 600 people to a full day of speeches and cultural events. The day included a rally and a march to Seattle's City Hall to witness the City Council's approval of the Boarding School Resolution, acknowledging the trauma and harm suffered by the American Indian and Alaskan Native community due to the American Indian Boarding School Policy between 1869 and the 1960s, which affected more than 100,000 AI/AN children. United Indians wrote a letter of support to the City Council in favor of the resolution, and organized the participation of hundreds at City Hall.

Later in the day, United Indians hosted an expansive and inclusive celebration at Daybreak Star Indian Cultural Center. A salmon dinner was served, followed by drumming and singing to honor Tribal veterans, and a speech by Resolution drafter Matt Remle.

Especially moving was the presence of hundreds of Elders and children, underscoring the transmission of the message from generation to generation that Indigenous peoples' history and culture matter.

How Tulalip Funds Were Spent

Your [REDACTED] grant was applied to \$4,533.93 in expenses for salmon and other food, supplies, and sound equipment, which all contributed to make this event a great success.
