Hope RISING Clinic 2022 Report

Reflecting on the past year, we are honored to continue working alongside our community and partners to meet the growing need for trauma-informed disability services for children in our region. Quil Ceda Village - Tulalip Tribes Charitable Fund's generous support in 2022 helped Wonderland serve a record number of children while growing to meet the evolving needs of families impacted by prenatal substance exposure (PSE).

In addition to supporting us in providing direct services, your contribution is helping Wonderland work with local partners and state advocates to expand access to prenatal substance exposure services statewide. There are an estimated 165,000 children in Washington State impacted by PSE and just one clinic offering comprehensive PSE services. With your help, we will scale and share our model to meet the true need for services in our state.

Your support enabled us to meet the following milestones in 2022:

- 131 children were enrolled in Hope RISING Clinic's life-changing services.
- Wonderland moved 35 kids off Hope RISING Clinic's waitlist and enrolled into services.
- Hope RISING Clinic implemented all four CDC-accredited, evidence-based interventions for FASD (fetal alcohol spectrum disorders).
- Wonderland partnered with local organizations, state agencies, and families impacted by PSE to work with state leaders to expand access to PSE services statewide.


Your funding supported Hope RISING Clinic families in making the following achievements:

- 97% of Hope RISING Clinic clients made measurable progress in two or more individualized treatment goals.
- 93% of Hope RISING Clinic caregivers reported an increased understanding of their child's disability and needs.
- 74% of caregivers reported measurable improvement in the frequency of their child's problematic behaviors.
- 71% of caregivers reported measurable improvement in the severity and frequency of their child's challenging behaviors.

Wonderland's partnership with Tulalip Tribes is enabling us to serve children awaiting critically needed prenatal substance exposure services today while paving the path to sustainable funding and access to services long term. Thank you for your support and partnership – this work wouldn't be possible without Quil Ceda Village - Tulalip Tribes Charitable Fund.
