Dear Ms. Sheldon,

On behalf of Wonderland and the children and families we serve, thank you for your continued support of Hope Rising Clinic. Your investment has been instrumental in helping us grow and strengthen services for families impacted by prenatal substance exposure (PSE).

We are pleased to share that 2025 has been a year of continued progress and impact. Building on the strong outcomes from 2024, Hope Rising Clinic has continued to expand its reach while deepening the support we provide to families.

In 2025, we served 141 children, with additional families in our intake process, and saw strong outcomes across clinical and family measures:

- 99% of children improved in two or more treatment plan goals
- 85% of parents reported an improved relationship with their child
- 77% of parents reported a decrease in challenging behaviors

In 2025, we have continued to build on this success by strengthening both clinical services and caregiver supports. Our Parent and Caregiver Education Program, piloted in late 2024, is now fully integrated into our model of care. Early feedback has been overwhelmingly positive, with caregivers reporting increased confidence, understanding, and ability to support their children. As one foster parent shared, *"Out of seven years of fostering, your caregiver program has been the best I've ever been part of."*

A key advancement this year has been the continued growth of our Family Care Fund. We know that insurance and public coverage typically address only a portion of the true cost of care. The Family Care Fund exists to bridge that gap—ensuring that no family is turned away or left with financial barriers to accessing services. This allows families to fully engage in care, reduce financial stress, and focus on their child's progress and well-being.

In collaboration with the Washington Health Care Authority, we are advancing implementation efforts tied to HB 1168 Washington State Prenatal Substance Exposure policy, helping to build a more informed and supportive system of care for families statewide.

At the same time, we are growing training opportunities for providers across Washington, strengthening the network of professionals equipped to support children and families impacted by PSE.

While demand for services continues to grow, we remain committed to ensuring that every child and family has access to the care and support they need. With partners like you, we are not only meeting immediate needs—we are helping to build a more responsive and equitable system for the future.
